## Legal basis:

## Law 81 of 2019 on Personal Data Protection.

**Art. 15 numeral 2:** Right of Rectification: allows the data owner to request the correction of their personal data that are incorrect, irrelevant, incomplete, outdated, inaccurate, false, or impertinent. **Article 16:** [...] the modification, [...] of the data will be absolutely free of charge and must be provided at the request of the owner of the data or whoever represents him, proof of the updated database concerning it. **Art. 17:** The data must be modified when they are erroneous, inaccurate, equivocal, or incomplete within a term of 5 business days following the request for modification. [...]

## Executive Decree 285 of 2021 regulating Law 81 of 2019 on the Protection of Personal Data.

**Art. 26:** Exercise of the right of rectification. When the owner of the data exercises the right of rectification, he must indicate in his request to which data he refers and the correction that must be made. It must accompany the documentation that supports the inaccuracy or incompleteness of the data being processed. [...]
